PUBLIC PARTICIPATION:

Frank Lattimore addressed the board regarding the speeding on Stryker Ave issue, the town will install there temporary speed signs in hopes this will resolve the issue. Councilmen Cornelius suggested they call the Sheriff's office to be added to the traffic issue list.

Frank DeOrio addressed to complaints of sewer odor in the Burtis Point neighborhood. The town has placed a sensor probe into the sewer manhole that will alert the town via text if an odor is present. Mr. DeOrio also suggested the use of a different carbon.

Presentation by Mike with Community Power Group as they are proposing to build a Solar Farm on 45 acres of land located at 113 Melrose Rd, Auburn NY.

The proposed solar farm should reduce the resident's energy bill. The life span of the farm is 25 years

The farm will boarder the Town of Sennett

The project would have to be below the fall zone of the cell tower that is also on the property.

The town has not received a formal application, the first step would be an application to the town code officer.

Walt Aikmen update on the wetland restoration project.

The NYS DEC made a visit to the site and and approced the excavation site work.

Doug Keirst from Soil and Water also visited adn suggested the ditches be lined with stone in a V-shape channel.

The restoration still is in need of the spray plan for the plantings, this can only be applied by a specialist that holds a NYS registered permit.

Councilmen Kerstetter suggested the town withdraw from the CC Mitigation Meetings as it is very extensive and time consuming and geared toward larger municipalities.

The board agreed and Councilmen Kerstetter will call and withdraw the town.
