## <u>RESOLUTION 18- 032</u> A RESOLUTION FOR AUTHORIZATION FOR THE ADVERTISEMENT AND SOLICITATION OF BIDS FOR THE TOWN OF OWASCO, OWASCO WATER DISTRICT IMPROVEMENTS OWASCO WATER MAIN REPLACEMENT PROJECT, CONTRACT NO. 1 – GENERAL CONSTRUCTION

WHEREAS, the Town of Owasco (Town) owns and operates a water system to meet the water demands within the Town and surrounding areas;

WHEREAS, various water system infrastructure is showing deficiencies and/or the infrastructure is approaching the end of its useful life;

WHEREAS, the Town of Owasco (Town) is proposing the Owasco Water Main Replacement Project (Project), located in the Town of Owasco, Cayuga County, New York, to address the deficiencies in the Town water system; WHEREAS, the proposed project will replace existing water mains along Route 38A, Melrose Road, Oakridge Road, and Archie Street and specifically will include the following:

• Replace approximately 4,250 feet of water main along Route 38A from Havens Avenue to Adams Avenue with 8" PVC water main;

• Replace approximately 3,800 feet of water main along Oakridge Road between Route 38A and Stryker Ave with 12" PVC water main;

• Replace approximately 900 feet of water main along Route 38A between White Bridge Road and Emerson Park with 8" PVC water main;

• Replace approximately 3,650 feet of water main along Melrose Road from Route 38A to just past Second Avenue with 8" PVC water main; and

•Replace approximately 250 feet of water main along Archie Street near Melrose Road with 8" PVC water main;

WHEREAS, by Resolution 17-203 adopted by the Town on 11.9.17 the Town Board declared its intent to assume the role of "Lead Agency" for purposes of conducting a SEQRA review of the Project and said Resolution stated, in part:

"RESOLVED, that the Supervisor of the Town of Owasco hereby is authorized to sign Part 1 of the Short Environmental Assessment Form; and it is

FURTHER RESOLVED, that the Town of Owasco Supervisor and the Town Board will circulate said Part 1 of the Short Environmental Assessment Form to the following list of "Interested and Involved Agencies" (New York State Department of Environmental Conservation, New York State Department of Transportation, New York State Historic Preservation Office (SHPO)a, Cayuga County Health Department, Cayuga County Highway Department, City of Auburn Municipal Utilities, Town of Owasco Water Department, and Town of Owasco Highway Department) under cover of a "Notice of Intent to Establish Lead Agency" letter for purposes of establishing Lead Agency status under the SEQRA/SERP;"

WHEREAS, on <u>November 2, 2017</u> a Notice of Public Hearing was published in The Citizen to consider adoption of the Town of Owasco Water Main Replacement Project, Phase 1, Map and Plan dated November 2017 in accordance with Town Law Section 202-b Increase or Improvements of Facilities. The Notice of Public Hearing stated:

"PLEASE TAKE NOTICE that a public hearing will be held by the Town Board of the Town of Owasco on Thursday November 9, 2017 at 4:00 p.m. at the Owasco Town Hall, 2 Bristol Avenue, Auburn, New York 13021 to consider adoption of the Town of Owasco Water Main Replacement Project, Phase 1, Map and Plan dated November 2017 in accordance with Town Law Section 202-b Increase or Improvements of Facilities.

Several water mains located in the Town of Owasco are undersized or reaching the end of their useful lives. Based on hydraulic review of the water system and discussion with the Owasco water operator it is proposed for the following sections of water mains to be replaced:

- Replace approximately 4,250 feet of water along Route 38A from Havens Avenue to Adams Avenue with 8" PVC water main;
- Replace approximately 3,800 of water main along Oakridge Road between Route 38A and Stryker Ave with 12" PVC water main;

- Replace approximately 900 feet of water main along Route 38A between White Bridge Road Emerson Park with 8" PVC water main;
- Replace approximately 3,650 feet of water main along Melrose Road from Route 38A to just past 2nd Avenue with 8" PVC water main;
- Replace approximately 250 feet of water main along Archie Street near Melrose Road with 8" PVC water main.

The maximum amount to be expended by Owasco Water District would be \$1,999,000.00

The estimated increases in annual user costs for the typical property in the Owasco Water District based on the proposed improvements is \$68.48 per year for 25 years";

WHEREAS, on 11.9.17, a Public Hearing was held and closed regarding the adoption of the Town of Owasco Water Main Replacement Project, Phase 1, Map and Plan dated November 2017;

WHEREAS, the Project is classified as "Unlisted" as defined by the State Environmental Quality Review Act (SEQRA) in 6 NYCRR Part 617.4;

WHEREAS, by Resolution 17-204 adopted by the Town on 11.9.17, the Town Board approved the Owasco Water District Improvements – Water Main Replacements, Phase 1, Map and Plan dated November 2017 pursuant to Town Law Section 202-b to acquire and construct Water Improvements as set forth therein at a maximum amount to be expended of \$1,999,000.00;

WHEREAS, on 11.15.17 the Town sent a letter and Part 1 of a Short Environmental Assessment Form (SEAF) to the potentially "Interested" and "Involved Agencies" (as this term is defined in the SEQRA Regulations found at 6 NYCRR Part 617), listed in Resolution 17-203 indicating the Town's desire to serve as the "Lead Agency" (as this quoted term is defined in the SEQRA Regulations) and to complete a coordinated review of the Project (in accordance with 6 NYCRR Part 617.6);

WHEREAS, responses from Interested and Involved Agencies were requested, and each of the potentially Interested and Involved Agencies has agreed to, or raised no objections to, the Town of Owasco Town Board serving as Lead Agency for the Project;

WHEREAS, by Resolution 17-230 adopted by the Town on 12.14.17 the Town Board determined that the proposed Owasco Water Main Replacement Project is an Unlisted Action and will not have a significant adverse impact on the environment and issued a Negative Declaration pursuant to SEQRA; and

WHEREAS, on 12.14.17 by Resolution 17-231 the Town Board passed a Bond Resolution authorizing the issuance of \$1,999,000.00 Serial Bonds to finance the cost of the Town of Owasco Water District Improvements.

NOW, THEREFORE, BE IT RESOLVED, that the Town of Owasco Town Board hereby directs the Advertisement For Bids for the Town of Owasco "Owasco Water Main Replacement Project, Contract No. 1 – General Construction" and the issuance of bid documents for response to said bids, with a bid opening on <u>Tuesday, February 27, 2018</u> at 10:00 am at which time any responsive bids shall be publically opened and read aloud; and it is further

**RESOLVED** that said bid documentation shall reserve the right to the Town of Owasco to reject all bids and to rebid the project at the Town Board's sole discretion; and it is further

**RESOLVED** that the Advertisement for Bids will be substantially similar to the text below:

"Sealed bids for the furnishing of all labor and material necessary for the Owasco Water Main Replacement Project, Contract No. 1 – General Construction will be received by the Town of Owasco Town Clerk at the Town Hall, 2 Bristol Avenue, Auburn, New York 13021 until <u>10:00 a.m.</u> local time <u>Tuesday, February 27, 2018</u> at which time and place they will be publicly opened and read aloud.

Bids will be received for the following:

**Base Bid:** The base bid generally includes the replacement of existing water main and the reconnection of water services along portions of Route 38A and Oakridge Road in the Town of Owasco. Approximately 2,047 feet of 8-inch PVC water main and appurtenances, 2,852 feet of 8-inch HDPE water main and appurtenances, 3,680 feet of 12-inch PVC water main and appurtenances, various water service transfers, various water main connections and 19 fire hydrants will be installed.

<u>Additive Bid No. 1</u>: Additive Bid No. 1 generally includes the replacement of existing water main and the reconnection of water services along a portion of Melrose Road and Archie Street in the Town of Owasco. Approximately 3,965 feet of 8-inch PVC water main and appurtenances, various water service transfers, various water main connections and 7 fire hydrants will be installed.

Contract Documents, including Advertisement For Bids, Information For Bidders, Labor and Employment, Additional Instructions, Bid Documents, Agreement, General Conditions, General Requirements, Specifications, Contract Drawings and any Addenda, may be examined at no expense at the office of Barton & Loguidice, D.P.C., 443 Electronics Parkway, Liverpool, New York 13088, or at the Town of Owasco Town Hall, 2 Bristol Ave, Auburn, New York 13021. Copies of the Contract Documents may be obtained on a CD from Barton & Loguidice, D.P.C., upon a non-refundable deposit of Twenty Dollars (\$20.00). Checks only shall be made payable to the Town of Owasco.

CASH DEPOSITS WILL NOT BE ACCEPTED. ALL HANDLING COSTS (MAIL, DELIVERY SERVICES, ETC.) SHALL BE THE RESPONSIBILITY OF THE BIDDER.

Each bid must be accompanied by security in an amount not less than five percentum (5%) of the amount of the bid in the form and subject to the conditions provided in the Information for Bidders. No Bidder may withdraw his bid within forty-five (45) days after the actual date of opening thereof.

The Town Board reserves the right to delay award up to 45 days after the actual date of opening thereof.

The successful bidder must furnish a 100 percent Performance Bond and a 100 percent Labor and Materials Bond with a surety company licensed in the State of New York.

This is an exempt capital improvement project, and Bidders shall not include in their bid sales and compensating use taxes on the cost of materials which are to be incorporated into the work and which are to be separately sold by the Contractor to the Town of Owasco prior to incorporation into the work of the Contract(s).

The attention of Bidders is particularly called to the requirements as to conditions of employment to be observed and minimum wage rates to be paid under the Contract(s).

The Town reserves the right to waive any and all irregularities and to reject any and all Bids or to rebid the project solely at the Town Boards discretion."
