Sheriff Schenck is going from town to town to introduce himself and let the town councils and residents know what programs and assistance they have to offer.

The biggest concern many towns & residents address the sheriff's offices is with traffic concerns, right now the sheriff office is short handed in their traffic division but soon will have more graduating from the academy, and new equipment coming in to aid the situation.

Their office has also become very proactive with many other issues that are a concern for the communities of Cayuga County. They have become very proactive and partnered with agency's to help with addiction issues, both as an out service as well as in the jail so when released they have a better chance of change. Other areas of concerns the office is addressing, domestic violence, scammers praying by phone, prescription take back programs, yellow dot program and more.

Mrs. White addressed the board & Sheriff regarding the legality of Drone usage in the town. \*Detective Lt, Fred Cornelius responded that as long as the drone is under 150 feet they are allowed over the property.
