A Resolution to Issue a Determination of Environmental Significance for Local Law No. 1 of 2011.

WHEREAS, the Owasco Town Board declares itself Lead Agency for the purpose of conducting the environmental review of said proposed action; and

WHEREAS, the Owasco Town Board has determined that the proposed action for adoption of Local Law No. 1 of 2011 is an Unlisted Action under the State Environmental Quality Review (SEQR) Regulations; and

BE IT RESOLVED, that the Owasco Town Board has determined that the adoption of the proposed Local Law No. 1 of 2011 will not have a significant adverse impact on the environment and hereby issues a Negative Declaration.

Resolution 11-101 A Resolution of the Town Board for the adoption and enactment of Local Law No. 1 of 2011.

WHEREAS, a Resolution was adopted by the Town Board on July 14, 2011 introducing proposed Local Law No. 1 of 2011 and said Resolution established a public hearing relating thereto; and

WHEREAS, a Notice of Public Hearing with respect to said proposed Local Law was duly published in The Citizen, the official Town newspaper and a newspaper circulated in said Town on August 5, 2011, and proof of such publication has been filed with the Town Clerk, and

WHEREAS, a Notice of Public Hearing with respect to such Local Law was duly posted on the sign board of the Owasco Town Hall, and

WHEREAS, a Public Hearing upon said proposed Local Law was held at the Owasco Town Hall, 2 Bristol Avenue, Auburn, New York 13021, in the Town of Owasco, New York on this date, August 11, 2011, pursuant to such Notice and an opportunity to be heard was given at said hearing to those favoring or opposing passage of said proposed Local Law; and

WHEREAS, the Owasco Town Board by Resolution passed on this date issued a Negative Declaration under SEQRA for Local Law No. 1 of 2011.

WHEREAS, the Town Board has carefully considered the proposed Local Law; and after due deliberation, finds it is in the best interest of the Town of Owasco to adopt said Local Law;

NOW, THEREFORE, AFTER DUE CONSIDERATION, IT IS HEREBY,

RESOLVED, that the Town Board of the Town of Owasco hereby approves and enacts Local Law No. 1 of 2011 set forth below:

§ 144-24. Meter reading; repairs and inspections; Discontinuance of Water Service.

- A. Employees of the Water Department, in the performance of their duties, shall be permitted to enter the premises of any consumer at any reasonable hour to remove, replace, repair or test the meter, to make a record of the quantity of water used, to inspect the premises to determine the manner of water use or to enforce the provisions of this chapter. If the Town is unable to access the premises to obtain a meter reading after one (1) year, a shut off notice will be sent to the property. In addition, there will be no monetary or usage credit for over estimates when the Town has been unable to obtain a meter reading.
- B. Water service may be discontinued by the Town for refusal of reasonable access to the property for the purpose of reading, repairing, testing or removing meters or inspecting water piping or other fixtures.
- C. No liability for shutting off water. Neither the Water Department nor the Town shall be liable for any damage which may result to any person or premises from shutting off the water from any main or service, for any purpose whatever, even in cases where no notice is given.
