Resolution 10-22 to approve the twelve month contract for 2010 between Finger Lakes Dog Protection Agency, INC. and the Town of Owasco for \$4620. payable in twelve monthly installments of three hundred eighty five dollars (\$385.00), \$25.00 fee per call for non-emergency after hour responses, \$8.00 per day for dog boarding fee for dogs seized and impounded, in accordance with the provisions of Article 7 of the Agriculture and Markets Law and/or any local law of ordinance. Transfer or euthanasia and disposal at the rate of \$40.00 per dog. The town shall be responsible for veterinary service cost for unidentified seized and /or impounded dogs during the statutory redemption period.

<u>Resolution 10-23</u> for the preparation of maps and plans for sewer services and related expenses in a portion of the Town to be known as Town of Owasco Sewer District No. 3 pursuant to Town Law 191-a.

WHEREAS, the Town Board of the Town of Owasco is considering providing sanitary sewer services to a portion of the Town to be known as Owasco Sewer District No. 3; and

WHEREAS, the Town Board of the Town of Owasco has sent out surveys to property owner in this portion of the Town to be known as Sewer District No. 3; and

WHEREAS, on March 12, 2009 by Resolution 09-061 the Town Board appropriated up to \$40,000 to pay the cost of preparing a general map and plan and related expenses for providing sewer services to a portion of the town to be known as Town of Owasco Sewer District No. 3, which is not currently included within the boundaries of the existing Town Sewer District No. 1 and Sewer District No. 2; and

WHEREAS, Resolution 09-061, pursuant to Town Law Section 191-a, was adopted subject to permissive referendum; and

WHEREAS, Resolution 09-061 was duly published in The Citizen on March 21, 2009; and

WHEREAS, the Town has appropriated \$40,000.00 for a general map, plan and report, an Environmental Review, (SEQR/SERP), and General Funding Assistance for the proposed Sewer District No. 3; and

WHEREAS, the Town by this Resolution would like to allocate up to an additional \$15,000 for a total of up to \$55,000 for expenses for the proposed Sewer District No. 3; and

BE IT RESOLVED, that the Town Board hereby adopts this resolution pursuant to Town Law Section 191-a appropriating up to an additional \$15,000.00 to pay the cost of preparing and completing a general map and plan and related expenses for providing sewer services to a portion of the town known as Town of Owasco Sewer District No. 3, which is not currently included within the boundaries of the existing Town Sewer District No. 1 and Sewer District No. 2;

FURTHER RESOLVED, that the expenses incurred for the preparation and completion of such maps and plans and related expenses shall be a town charge, and shall be assessed, levied and collected in the same manner as other town charges; and

FURTHER RESOLVED, that if the Town Board shall thereafter establish or extend a sewer district and construct a sewer system pursuant to the Town Law, the expenses incurred by the Town for the preparation of the maps and plan and related expenses shall be deemed to be part of the cost of such improvement, and the Town shall be reimbursed the amount paid therefore, or such portion of that amount which the Town Board, at the public hearing held pursuant to Town Law Section 194, shall allocate against such district; and

FURTHER RESOLVED, that pursuant to Town Law Section 191-a, this Resolution is adopted subject to a permissive referendum.

WHEREAS, a written petition dated 7/6/2009 has been submitted in due form by Mark R. Anderson and Susan Anderson, containing the required signatures, which has been presented and filed with the Town Board of the Town of Owasco, Cayuga County, New York, for the establishment of an extension to the Town of Owasco Sewer District No. 1, which is bounded and described on Exhibit A attached hereto and made a part hereof which is the legal description for 6012 Oakridge Road in the Town of Owasco, Tax Map No. 123.04-1-71, and

WHEREAS, the improvements proposed consist of the construction and maintenance of sanitary sewer system to serve said extension in the district in accordance with certain plans to be submitted to the Town, and

WHEREAS, it is the intention of the petitioner to construct or the petitioner has constructed said sanitary sewer and has connected with the Town sewer main or line at their own expense and said sanitary sewer to remain the property of the petitioners and not transferred to the Town, at an annual charge to be determined by the Town Board as well as quarterly sewer bills

NOW, THEREFORE, be it ORDERED, that the Town Clerk call a Public Hearing at a meeting of the Town Board of the Town of Owasco when the Petitioners submit a map, plan and report approved by the Town Engineers to consider said petition including the environmental significance thereof and to hear all persons interested in the subject thereof, and for such other and further action on the part of said Town board, with relation to the premises."

WHEREAS, after consultation with the DEC, the Town desires to move forward with the extension without the need for a map, plan and report as the sanitary sewer line installed was at the expense of the petitioners/property owner and is to remain the property of the petitioners/property owner and not transferred to the Town.

NOW, THEREFORE, be it RESOLVED, that the Town Clerk call a Public Hearing for Thursday, February 11, 2010 at 7 pm on the proposed Sewer District No. 1 Extension for 6012 Oakridge Road in the Town of Owasco, Tax Map No. 123.04-1-71 owned Mark R. Anderson and Susan Anderson;

FURTHER RESOLVED, that the Town Board declares itself lead agency and that said action is an Unlisted Action under SEQRA and directs the Town Clerk to provide a copy of the Short Environmental Assessment Form to the Cayuga County Health Department and the New York State Department of Environmental Conservation for any comments.
