## Resolution 10-218 General Efficiency Planning Grant Program

WHEREAS, the County of Cayuga ("County") currently is party to agreements with twenty-two (22) municipalities within the County with respect to snow and ice removal on County-owned roads in the municipalities; and

WHEREAS, Cayuga County and several of the towns (the "Towns") wish to determine whether there are additional operational and cost efficiencies to be obtained by consolidating certain highway services (the "Services") with the various municipalities within the County; and

WHEREAS, the County and Towns desire to apply for General Efficiency Planning Grant Program funding to assist with the study and analysis of the issues related to the consolidation of the Services (the "Study");

### NOW, THEREFORE, IT IS RESOLVED:

- 1. The Town of Owasco hereby authorizes the County to submit an application through the General Efficiency Planning Grant Program for the conduct of the Study. The County shall act as Lead Applicant and the Towns of Mentz, Throop, Sennett, Owasco and Ira shall act as co-applicants, with the respective Supervisors of each Town acting as Co-Applicant Contact Person. The Lead Applicant Contact Person shall be the County Administrator, Thomas Squires, or his designee. The Lead Applicant Contact Person shall execute all financial and/or administrative process relating to the grant program.
- 2. The project for which the grant application shall be submitted is as follows: The County and the Towns wish to conduct the Study, which will determine whether there are operational and cost efficiencies to be achieved by virtue of consolidating the Services, or any other consolidations or sharing of services that may be suggested by the Study.
- 3. The maximum amount of money to be applied for in the grant application shall be \$29,000 (local share of \$13,000).
- 4. The County and Towns shall act in compliance with the State Environmental Quality Review Act when applicable to any aspect of the conduct of the Study.
- 5. The local share or match for the grant funds shall be contributed by the County.

<u>Resolution 10-221</u> A resolution of the Town Board to amend a portion of Section 508 of the Town of Owasco Employee Handbook titled "Supplies, Tools and Equipment, and Fuel Usage"

Whereas, Section 508 of the Town of Owasco Employee Handbook reads:

"508 Supplies, Tools and Equipment, and Fuel Usage

Supplies – All Town owned supplies must be used efficiently and not wasted. An employee may not use any Town supplies including, but not limited to, postage, paper, or office supplies for personal use.

Tools and Equipment – With prior approval of the Highway Superintendent, an employee may be permitted personal use of Town owned small hand tools. If a tool is removed from Town premises, the employee must indicate on a sign-out log when the item is taken and when it is returned. The sign-out log will include a disclaimer releasing the Town from any liability of damage or injury related to use of Town-owned tools or equipment. No Town equipment, supplies, or other material may be used by an employee for monetary gain. The employee must repair or replace any Town-owned tool or piece of equipment lost or damaged by the employee as a result of negligence or intentional misuse.

Fuel – An employee may not use gasoline, fuel oil or motor oil purchased by the Town for personal use."

RESOLVED, that the Town Board hereby amends paragraph entitled "Tools and Equipment" in Section 508 of the Town of Owasco Employee Handbook to now read:

"Tools, Equipment and Facilities – An employee may not use any Town Tools, Equipment or Facilities for personal use."
