## WITNESSETH:

That the Grantors, in consideration of One Dollar and 00/100 (\$1.00) and other valuable consideration paid by Grantee, the receipt of which is hereby acknowledged, does hereby grant, sell and convey to the Grantee, its successors and assigns, a permanent right-of-way and easement upon, along, above, over, through, in, across, and under a portion of the Grantors' property located in the Town of Owasco, County of Cayuga, and State of New York and being more particularly described as seven feet and six inches (7.5) feet either side of the centerline, which centerline is the location of the Town's Sanitary Sewer Mains or pipes, manholes, pumps, sewer laterals and appurtenances thereto.

It being intended to describe a strip of land ten (15) feet wide for said right-of-way and easement which shall be seven feet and six inches (7.5) feet either side of the Town's Sanitary Sewer Mains or pipes, manholes, pumps, sewer laterals and appurtenances thereto installed or to be installed by Grantee.

Said right-of-way and easement for the passage of people, vehicles and equipment are for

the purpose of constructing, reconstructing, operating, repairing, and maintaining upon, along, above, over, through, in, across, and under said parcel of land the Town's Sanitary Sewer Mains or pipes, manholes, pumps, sewer laterals and appurtenances thereto, and to make such construction and excavation and to perform such work as may be necessary or proper to accomplish the aforesaid.

The Grantor, his/her/its successors and assigns, will not erect any structure on the aforesaid easement and right-of-way, and agrees not to do any act which would interfere with or hinder the construction, reconstruction, or maintenance of the proposed improvements to be made therein. The Grantor, his/her/its successors and assigns, shall continue to have free and absolute access to and over the said easement and right-of-way, provided the improvements to be constructed by Grantee shall not be damaged or interfered with.

This is a covenant running with the land hereby, and the Grantor, his/her/its successors and assigns, release Grantee from any and all claims of damages to the property or lands within the bounds of said easements. The Grantee agrees that after the installation or repair of the Town's Sanitary Sewer Mains or pipes, manholes, pumps, sewer laterals and appurtenances thereto, it will restore the surface of the ground to a similar condition as it was before the construction.

This easement and right of way shall run with the land and shall be binding on the Grantor's successors and assigns and the Grantee's successors and assigns.

TO HAVE AND TO HOLD the rights hereby unto the said Grantee, its successors and assigns, forever.

And said Grantor covenants as follows: First, that the Grantee shall quietly enjoy the said premises; and second, that the said Grantor will forever warrant title to the said premises.
