The Town will receive an \$825,000.00 grant from the Environmental Facilities Corporation for the Sewer District #1 Melrose Road/Havens Ave Project. The total cost of the Project is \$1,569.000.00. Also included is a low-interest loan for the remainder of the cost of the project. The money came directly from the Federal Economic Stimulus program funded through the New York State Environmental Facilities Corporation. The cost to the taxpayers in Sewer District #1 will be drastically reduced by the grant and the low-interest loan.
