<u>Resolution 16-026</u> to schedule a Public Hearing for Local Law No. 2 of 2016 To Appoint a Town Board Member as a Liaison of the Town of Owasco Sewer Districts Nos. 1, 2 and 3 and the Town of Owasco Water District.

**WHEREAS**, the Town of Owasco is in the process of going out to bid for what is known as the "Owasco Sewer System Improvements" to construct Sewer District No. 3 with upgrades to existing Sewer Districts Nos. 1 and 2;

**WHEREAS**, the Town of Owasco is in the process of going out to bid for what is known as the "Owasco Water District Improvements";

WHEREAS, in an effort to reduce costs for the Owasco Sewer System Improvements project and the Owasco Water District Improvements project and at the discretion of the Town Board, continuing thereafter after the completion of the projects, the Town Board has determined that a Liaison be appointed for Owasco Sewer Districts Nos. 1, 2 and 3 and to act as a liaison to the Town Board;

<u>Resolution 16-031</u> To accept the Pre-Selection Bid of Xylem Water Solutions USA, Incorporated Base Bid in the Amount of \$437,142.00 and Alternate Add On in the amount of \$21,384.00, for a total award of \$458,526.00.

**WHEREAS,** on December 2, 2015 by Resolution 15-240 the Town Board authorized the Town to advertise for bids for Grinder Pump Station Pre-Selection for Sewer District No. 3 per the Contract Documents dated December 2015, prepared by Barton & Loguidice, D.P.C., as amended including Addendum No. 1; and

**WHEREAS**, the Contract Documents include the Advertisement for Bids, Information for Bidders, Bid Documents, Agreement, Specifications, and any Addenda; and

**WHEREAS**, the Specifications for the grinder pump pre-selection were developed in accordance with New York State Environmental Facilities Corporation requirements; and

**WHEREAS**, the purpose of the pre-selection was to solicit unit prices and proposals for the supply of all grinder pump stations to be installed as part of the Owasco Sewer System Improvements Project, which includes Sewer District No. 3; and

**WHEREAS**, the construction of the project will be publicly bid, and the Town of Owasco's General Contractor will be mandated to purchase and install the grinder pump stations selected; and

**WHEREAS**, the Advertisement For Bids states that "The Owner reserves the right to reject any Bids, at his own discretion, on the basis of the Bidder's qualifications and product qualifications

WHEREAS, the Advertisement For Bids also states "THE RIGHT IS RESERVED BY THE TOWN BOARD OF THE TOWN OF OWASCO TO REJECT ANY OR ALL BIDS, IN WHOLE OR IN PART, AS MAY BE DEEMED IN THE BEST INTEREST OF THE TOWN OF OWASCO. THEIR DECISION SHALL BE FINAL AND BINDING;" and

WHEREAS, the Information for Bidders at § 8.0 states that "The Owner reserves the right to reject any or all Bids when such rejection is in the interest of the Owner, and to reject the Bid of a Bidder, who in the judgment of the Owner, is not in position to perform the agreement resulting from the acceptance of the Bid. The Owner does not in any way obligate itself to accept any Bid;" and

WHEREAS, the Information for Bidders at § 12.0 states that "The Owner's selection of a grinder pump manufacturer will not be based solely upon the lowest unit prices submitted in the Bid," and any award of the winning Bid would be subject to the terms and the provisions contained in the Information for Bidders, which as stated above allows the Owner to reject any Bid that is not in the best interest in the Town of Owasco; and

WHEREAS, the Advertisement For Bids for the Town of Owasco Sewer District No. 3 Grinder Pump Station Pre-Selection for Sewer District No. 3 was duly published in The Citizen on December 4, 2015; and

**WHEREAS**, on December 18, 2015, the Town received and opened bids for the Town of Owasco Sewer District No.3 Grinder Pump Station Pre-Selection; and

**WHEREAS**, the summary of bids received are as follows:

Environmental One Corporation ("E-One")	Base Bid Alternate Add On Total	\$413,072.00 \$26,730.00 \$439,802.00
Xylem Water Solutions USA, Incorporated ("Xylem")	Base Bid Alternate Add On Total	\$437,142.00 \$21,384.00 \$458.526.00:

**WHEREAS,** that the Town Board duly considered all information supplied by the Bidders, and compared the Xylem pump and the E-One pump, and considered the following:

• Xylem took no exceptions to the warranty requirements as stated in the specifications.

Xylem took no exceptions or included any cost in its bid to maintain the equipment in warrantable condition. E-One's bid contained a limited warranty, "... provided that the product is properly installed, serviced and operated under normal conditions and according to manufacturer's instructions." Normal conditions include items on the do not flush list, which can void the warranty.

- There are two shaft seals on the Xylem pump which operate in an oil bath. This design protects the motor cavity and prevents the entrance of sewerage. The upper seal is carbon/ceramic and lower seal is ceramic/tungsten carbide. The e/One pump has only one mechanical seal. All sewage must pass through the spring of this seal, which increases the likelihood that the seal will fail, leading to catastrophic motor failure.
- The Xylem pump uses a hardened iron cutter wheel throughout and a stainless steel shredder ring. The E-One pump uses a surface hardened cast iron cutter wheel and a cast iron shredder ring.
- The Xylem pump uses a trickle impregnated motor insulation that will reduce hot spots in the motor.
- The over temperature sensor in the motor windings of the Xylem pump is wired directly to the control panel. This allows a troubleshooting advantage over the e/One pump. Both have over temperature sensors imbedded in the winding of the motor, however the e/One pump must be pulled and disassembled for testing.
- The lower motor bearing in the Xylem pump has a double row of ball bearings providing greater support of the motor shaft, especially when the pump is operating at higher pressures. The E-One pump has a single row bearing.
- The Xylem pump is supplied with a capacitor start and a capacitor run motor that is more efficient than the capacitor start motor in the E-One pump.
- The Xylem tank (basin) is a molded tank, while the E-One tank is fabricated from drain pipe.
- The Xylem tank does not have the dry/wet divider allowing for greater storage capacity in case of power outage
- The Xylem tank is designed so a concrete ballast is not required for direct burial.
- Xylem tank allows for the location of the inlet to align with the sewer lateral from the home eliminating additional fittings. The E-One pump basin inlet is 180 degrees from the outlet.

- The Xylem pump is rated as a submersible pump. The E-One pump assembly is not designed to be completely submerged.
- The level sensing controls with the modified E-One (motor starting controls located in the alarm panel) are still located in a two- piece plastic housing that is part of the pump assembly. This assembly depends on a gasket between the two parts of the housing to keep moisture out. E-One redesigned the motor housing because of problems with a gasket. The same problem potentially exists with the pressure switch housing, especially in case the assembly is submerged in a power loss situation; and

**WHEREAS,** The Board has concluded Xylem pump system is an upgrade of the E-One pump design and the Town has reasonably concluded that the Xylem pump will operate with fewer service calls and lower repair costs, rendering a great benefit to the Town, its officials, employees, and the Town residents; and

**WHEREAS**, that the Town Board expects that maintenance costs will decrease for Sewer District No. 3 due to Town's Sewer Department ability to perform routine repairs eliminating the need to outsource all service calls.

**NOW, THEREFORE, BE IT RESOLVED,** that the Town of Owasco Town Board hereby accepts the Pre-Selection Bid of Xylem Water Solutions USA, Incorporated Base Bid in the amount of \$437,142.00 and the Alternate Add On in the amount of \$21,384.00 for a total award of \$458,526.00, which represents the best value for the Town; proposal responsiveness, price, performance, warranty, and future benefits for the Town included.

#### **Resolution 16-032**

A RESOLUTION FOR AUTHORIZATION FOR THE ADVERTISEMENT AND SOLICITATION OF BIDS FOR THE TOWN OF OWASCO, OWASCO SEWER SYSTEM IMPROVEMENTS CONSTRACT NO. 1 FOR OWASCO SEWER DISTRICTS NOS. 1, 2 AND 3.

**WHEREAS**, the Town of Owasco (the "Town") through a referendum created Sewer District No. 3 in the Town of Owasco, Cayuga County, New York (the "Project"); and

**WHEREAS**, on November 12, 2009 the Town Board passed **Resolution 09-189** declaring this project a Type I Action under the New York State Environmental Quality Review Act

("SEQRA") and within the meaning of 6 NYCRR 617.2 and establishing the Owasco Town Board as Lead Agency for the Project; and

**WHEREAS**, within the Description of Action in Part 1 of the Full EAF it includes improvements to existing Sewer Districts Nos. 1 and 2 as it states "Capacity Improvements to the Burtis Point Pump Station, Oakridge Pump Station, and/or the Town's existing gravity sewers may be implemented as part of this project, if necessary."; and

WHEREAS, on April 8, 2010 the Town Board passed Resolution 10-065 declaring that the Project constitutes a "Type 1 action"; and no significant adverse environmental impacts are noted in the EAF for the Project and none are known to the Town Board. Therefore, the Town Board hereby determines that the Project will not have a significant adverse environmental impact and will not require the preparation of a Draft Environmental Impact Statement with respect to the Project and issues a Negative Declaration; and

**WHEREAS,** the Town Board has received Owasco Sewer District No. 3 Town of Owasco, Cayuga County, New York Map, Plan and Report dated August 2014 from the Town Engineer, Barton & Loguidice; and

**WHEREAS,** Sewer District No. 3 will extend public sewer service southerly from the existing Sewer District No. 2 boundary and will generally serve lakeshore areas and properties along Owasco Lake south of Burtis Point and Rockefeller Road up to and including Koenig Point Drive; and

**WHEREAS,** on August 27, 2014 the Town Board hereby accepted the Owasco Sewer District No. 3 Town of Owasco, Cayuga County, New York Map, Plan and Report dated August 2014; and

**WHEREAS,** public hearings were held by the Town Board of the Town of Owasco on Saturday October 4, 2014 at 1:00 p.m. and Thursday October 9, 2014 at 5 pm both at the Owasco Fire House, 7174 Owasco Road, Auburn, New York 13021 regarding the establishment of Town of Owasco Sewer District No. 3; and

**WHEREAS,** on November 13, 2014 the Town Board continued and then closed the Public Hearing; and

**WHEREAS**, on November 13, 2014 by Resolution 14-164 the Town Board adopted a Resolution and Order authorizing the establishment of Sewer District No. 3, including the cost of improvements and expenses necessary in connection therewith at a maximum estimated cost of **\$3,964,400.00**, in the Town of Owasco, subject to a referendum; and

**WHEREAS**, said Resolution 14-164 from November 13, 2014 does not take effect until a proposition for the approval thereof has been approved at a Special Election by the qualified owners of taxable real property situated in said proposed Sewer District No. 3, as shown upon the latest completed assessment roll of the Town; and

**WHEREAS**, on November 13, 2014 this Town Board desired to call such a special election of said Town for the submission of such proposition; and

**WHEREAS**, a Special Town Election of the qualified voters in the Town of Owasco being owners of taxable real property situated in the proposed Sewer District No. 3 pursuant to Rules adopted by the Town Board for the purpose of submitting a proposition of the question of approving or disapproving an Order was held on December 17, 2014; and

**WHEREAS,** pursuant to the Certificate of Inspectors of Election the Proposition and Order passed on December 17, 2014 with vote totals as follows: 117 votes were in favor with 45 opposed to the proposed Proposition or Order to establish Sewer District No. 3 set forth below:

#### "PROPOSITION

Shall the Order dated and duly adopted November 13, 2014 by the Town Board authorizing the establishment of Sewer District No. 3, in the Town of Owasco, Cayuga County, New York, with improvements, consisting of approximately 15,408 L.F. of pressure mains and approximately 162 grinder pump stations, improvements to the Burtis Point Pump Station and improvements to the Oak Ridge Pump Station and Force Main and improvements to the Owasco Interceptor Sewer to provide public sewers to all the Lakeshore properties from Brook Hollow Drive to and including Koenig Point and other properties in the same area, as well as land or rights in land, original furnishings, equipment, machinery and apparatus incidental thereto, at a maximum estimated cost of \$3,964,400.00, said cost to be financed by the issuance of general obligations serial bonds over a period not exceeding 30 years, to be payable in the first instance from user charges upon the real property in said Sewer District No. 3, which shall be bounded and described as set forth in proceedings for the establishment thereof on file in the Town Clerk's Office, be approved?"; and

WHEREAS, on January 8, 2015 the Town Board passed Resolution 15-009 which stated in part:

"The Town Board hereby adopts and approves the aforesaid Order and Proposition voted on and approved at the December 17, 2014 authorizing the establishment of Sewer District No. 3, including the cost of improvements and expenses necessary in connection therewith at a maximum estimated cost of \$3,964,400.00, in the Town of Owasco set forth below:

ORDER: The Town Board authorizes the establishment of Sewer District No. 3, in the Town of Owasco, Cayuga County, New York, with improvements, consisting of approximately 15,408 L.F. of pressure mains and approximately 162 grinder pump stations, improvements to the Burtis Point Pump Station and improvements to the Oak Ridge Pump Station and Force Main and improvements to the Owasco Interceptor Sewer to provide public sewers to all the Lakeshore properties from Brook Hollow Drive to and including Koenig Point and other properties in the same area, as well as land or rights in land, original furnishings, equipment, machinery and apparatus incidental thereto, at a maximum estimated cost of \$3,964,400.00, said cost to be financed by the issuance of general obligations serial bonds over a period not exceeding 30 years, to be payable in the first instance from user charges

upon the real property in said Sewer District No. 3, which shall be bounded and described as set forth in proceedings for the establishment thereof on file in the Town Clerk's Office."; and

**WHEREAS,** on May 14, 2015 the Town board passed Resolution 15-101 modifying the January 8, 2015 Resolution 15-009 and adopted and approved the Order and Proposition voted on and approved at the December 17, 2014 Special Election authorizing the establishment of Sewer District No. 3, including the cost of improvements and expenses necessary in connection therewith at a maximum estimated cost of \$3,964,400.00 in the Town of Owasco; said Resolution also made specific determinations and findings pursuant to Town Law Section 209-e, namely:

- "(a) The notice of hearing was published and posted as required by law, and is otherwise sufficient;
- (b) All the property and property owners within the proposed Sewer District No. 3 are benefited thereby;
- (c) All the property and property owners benefited are included within the limits of the proposed Sewer District No. 3;
- (d) The establishment or extension of such Sewer District No. 3 is in the public interest.

The Town Board hereby adopts this resolution approving the establishment of Sewer District No. 3 as the boundaries shall be finally determined and the construction of the improvement or providing of the service therein as set forth in the approved Map, Plan and Report of August 2014."; and

**WHEREAS**, at the request of the New York State Comptroller, the Town Board needed to determine the equivalent dwelling units to be assessed against those parcels in Appendix K of the Map, Plan and Report for Sewer District No. 3 that were currently shown to have zero equivalent dwelling units; and

**WHEREAS**, on June 22, 2015 by Resolution 15-133 the Town Board scheduled a public hearing to consider assessing the said undevelopable lots a .01 equivalent dwelling unit assessment; and

**WHEREAS**, a Notice of Public Hearing was duly published in the The Citizen on July 11, 2015; and

WHEREAS, a Public Hearing was held on this date, July 22, 2015; and

**WHEREAS**, pursuant to the approved Map, Plan and Report for Sewer District No. 3 the average annual equivalent dwelling unit assessment is approximately \$768 and as such a .01

equivalent dwelling unit assessment for the 13 identified undevelopable lots would be approximately \$7.68 per year per lot; and

**WHEREAS**, the New York State Comptroller by Order dated July 9, 2015 and filed at the Town Clerk's Office on July 14, 2015, approved the Town's application for permission to establish Sewer District No. 3 and permitted the establishment of said District; and

**WHEREAS,** on July 22, 2015 by Resolution 15-157 the Town Board modified and amended the approved Map, Plan and Report for Sewer District No. 3 dated August 2014 and assesses undevelopable lots in Sewer District No. 3 an equivalent dwelling unit of .01 per lot; and

**WHEREAS**, on December 2, 2015 by Resolution 15-240 the Town Board authorized the Town to advertise for bids for Grinder Pump Station Pre-Selection for Sewer District No. 3 per the Contract Documents and Specifications dated December 2015 prepared by Barton & Loquidice D.P.C; and

**WHEREAS**, the Advertisement For Bids for the Town of Owasco Sewer District No. 3 Grinder Pump Station Pre-Selection for Sewer District No. 3 was duly published in The Citizen on December 4, 2015; and

**WHEREAS**, on December 18, 2015 the Town received and opened bids for the Town of Owasco Sewer District No.3 Grinder Pump Station Pre-Selection

**WHEREAS,** on this date by Resolution 16-031 the Town Board accept the Pre-Selection Bid of Xylem Water Solutions USA, Incorporated Base Bid in the amount of \$437,142.00 and Additive Bid in the amount of \$21,384.00 for a total award of \$458,526.00.

**WHEREAS,** on January 21, 2015 by Resolution 15-037 the Town Board approved and accepted the Map and Plan for Sewer District No. 1 Improvements dated January 2015;

**WHEREAS,** on January 21, 2015 by Resolution 15-038 the Town Board approved and accepted the Map and Plan for Sewer District No. 2 Improvements dated January 2015;

**WHEREAS**, on February 12, 2015 by Resolution 15-053 the Town Board passed a Bond Resolution authorizing the issuance of \$2,901,000.00 Serial Bonds to finance the cost of Improvement For Sewer District No. 2;
