The following portion of the Table of Dimensional Requirements pursuant to Section 150-21 of the Town Code of the Town of Owasco is amended as follows:

Principal Building Lot Line Setbacks, Side, for Zoning District R for the following Permitted Uses:

Single-family farm dwellings, Single-Family Dwellings (1), Single-Family Dwellings (2), Two-Family Dwelling (1), Two-Family Dwelling (2) to be 15 feet (Ft.).

Principal Building Lot Line Setbacks, Side, for Zoning District L for the following Permitted Uses:

Single-Family Dwellings and Cottages (1), Single-Family Dwellings and Cottages (2), Two-Family Dwellings (1), Two-Family Dwellings (2) to be 15 feet (Ft.).

The remaining portions of the Table of Dimensional Requirements shall remain in full force and effect.
