Resolution 09-143 authorizing the City of Auburn to apply for funding under the New York state local government efficiency grant program September 10, 2009

WHEREAS, the City of Auburn, in collaboration with the Town of Aurelius, Town of Fleming, Town of Owasco, Town of Sennett, Town of Throop, and the Cayuga County Water & Sewer Authority are submitting an application to the New York State 2009- 2010 Local Government Efficiency (LGE) Grant Program in an effort to form and implement a new regional water and sewer agency,

WHEREAS, the LGE Grant Program has announced that it will accept applications for its "Efficiency Implementation Grant Program", where the above participating governmental agencies have agreed to apply for \$1,000,000 in funding assistance, including a 10 percent matching local share; and

WHEREAS, the LGE Grant Program provides technical assistance and awards financial support for projects that will improve municipal efficiency and reduce costs through shared services, cooperative agreements, mergers, consolidations and dissolutions; and

WHEREAS, the Town of Owasco is supportive of the proposed project for the consolidation of water and sewer services to form a regional agency, which has the potential for municipal cost savings; and

WHEREAS, an application entitled the "Cayuga Regional Water and Sewer Authority Implementation Project" would consist of four primary goals 1) Complete a cost of service analysis and outline inter-governmental agreements with communities; 2) Prepare and submit legislation for New York State approval; 3) Transition and implement the new water and sewer regional structure; and 4) Initiate capital improvements that will enhance the regional delivery of water and sewer services; and

WHEREAS, the Cayuga Regional Water and Sewer Authority Implementation Project will consist of two phases, the first phase which includes the completion of the cost of service analysis and the outlines of inter-governmental agreements has an anticipated cost of \$140,500 with a local match of \$14,050 that will be funded by the following governmental agencies:

- 1) The City of Auburn is committed to providing \$10,450 of the local share of the project cost, and
- 2) The Towns of Aurelius, Fleming, Owasco, Sennett and Throop as well as the Cayuga County Water & Sewer Authority are committed to providing \$600 from each participant towards the local share of the project cost, for a total \$3,600; and

WHEREAS, each entity will work cooperatively to share all necessary information in a timely manner to facilitate this grant application and implementation of the water and sewer agency; and now, therefore

BE IT RESOLVED, by the Town of Owasco, New York that it commits to working in partnership with the City of Auburn, the current participating Towns, and the Cayuga County Water & Sewer Authority to consider the possibilities of forming and implementing a regional water and sewer agency for the benefit of sharing and/or consolidating water and sewer services among the communities; and

BE IT FURTHER RESOLVED, by the Town of Owasco, New York that the City of Auburn is hereby authorized to enter into an Inter-municipal Shared Services Agreement(s) with the other participating governmental agencies, that will be contingent on the awarding of the grant, setting forth individual responsibilities for the implementation of the project including, but not limited to, the required financial commitments and sharing of information, subsequent to the approval of terms and conditions therein by the Town of Owasco legal counsel.

BE IT FURTHER RESOLVED, that the Towns of Aurelius, Town of Fleming, Town of Owasco, Town of Sennett, Town of Throop, and the Cayuga County Water & Sewer Authority specifically represent that any further contribution beyond the \$600 approved herein by each participant will require further approval and authorization by each participants respective boards.
