#### PUBLIC PARTICIPATION:

Presentation by Eileen O'Conner\_with Cayuga County Health Department will speak regarding the water plant filtration issues.

Eileen O'Connor with the Cayuga County Health Department -Environmental Division spoke on the concerns with the toxins that made its way into both the Town of Owasco's treated water and the City of Auburn's this past summer and the concerns it may happen again in the coming summer. State Health officials in Albany who conducted the testing of the water were surprised as the system both the town and city have in place should have stopped the toxins from entering the treated water. Given this fact she is strongly encouraging cities and towns to be ready in case the situation arises again in the upcoming summer. The City of Auburn has hired GHD to evaluate their water treatment plant's needs, she also noted that each plant is different and what works for one may not work for the other. Supervisor Wagner noted that EFC will be giving up to \$75, 000.00 to the city and Town of Owasco for evaluation of our water treatment plant.

WHEREAS, a Short Environmental Assessment Form (SEAF) must be completed and circulated to all interested and involved Agencies for purposes of establishing the Town Board as "Lead Agency" in accordance with 6NYCRR Part 617 for the purpose of conducting a SEQRA/SERP review of the Project.

**RESOLVED,** that the Town of Owasco Supervisor and Town Board, together with the Town of Owasco Attorney are hereby authorized to take all actions, serve all notices, and complete all documents in order to give full force and effect to this determination.
