<u>Resolution 16-143</u> to authorize the Town Supervisor to sign Change Order No. 4 for the Owasco Sewer System Improvements Project Contract No. 1.

WHEREAS, this Change Order includes the following additional work items:

The furnish of a grinder pump alarm panel generator receptacle with auto transfer bid item was inadvertently omitted from the contract documents. The alarm panels are currently being ordered with a generator receptacle per the contract specifications, but currently there is no way to reimburse the contractor for this item. This change order will add the bid item "CO4-1 – Furnish Alarm Panel Generator Receptacle" with a quantity of 161 and a unit price of \$138.60. The unit price for this item was determined during the Town of Owasco Grinder Pump Pre-Selection Bid to be \$132.00 and will be marked up 5% to \$138.60 to cover the contractor's bond/insurance and overhead/profit (generally accounted for in other bid items).

WHEREAS, the execution of this Change Order will result in an increase in approximately **\$22,314.60** to the Contract Amount.

WHEREAS, upon recommendation of the Town Engineer, Clerk of the Works and the Town Board Liaison

NOW THEREFORE BE IT RESOLVED that the Town Supervisor is hereby authorized to sign Change Order No. **4** for the Owasco Sewer System Improvements Project Contract No. 1 and hereby consents to the Town Engineer signing same Change Order No. **4**.
