<u>Resolution 16-131</u> to authorize the Town Supervisor to sign Change Order No. 1 for the Owasco Sewer System Improvements Project Contract No. 1.

WHEREAS, this Change Order includes the following additional work items:

This change order is for the open cut sewer replacement of the interceptor sewer from MH 6-16 to MH 6-4. Originally, this section of sewer was projected to be CIPP lined. However, the contractor expressed

interest in open cutting this section of sewer and provided the attached pricing. The open cut replacement of MH 6-16 to MH 6-4 pricing includes new 15" SDR35 PVC pipe, new precast concrete manholes, restoration, excavation, granulars, and lateral reconnections. The finished product of an open cut sewer would not only include all brand new sewer infrastructures (compared to the rehab of existing), it would increase capacity of the sewer line and fix several sections of sewer main with slopes that do not meet current design standards.

WHEREAS, the execution of this Change Order will result in an increase in approximately \$19,877.00 to the Contract Amount.

<u>Resolution 16-132</u> to authorize the Town Supervisor to sign Change Order No. 2 for the Owasco Sewer System Improvements Project Contract No. 1.

WHEREAS, this Change Order includes the following additional work items:

Town of Owasco personnel cleared several trees and installed several access roads along the interceptor sewer main. The contractor originally bid the project under the assumption that they would have to complete this work. The contractor is offering a \$13,500.00 credit on Bid Item TS-3 Clearing. The contractor will be required to remove the access roads at the completion of construction;

WHEREAS, the execution of this Change Order will result in a **decrease** of \$13,500.00 to the TS-3 Clearing (TS Items only) Bid Item; and

<u>Resolution 16-133</u> to authorize the Town Supervisor to sign Change Order No. 3 for the Owasco Sewer System Improvements Project Contract No. 1.

WHEREAS, this Change Order includes the following additional work items:

The contractor has encountered unforeseen rock along the interceptor which has slowed down production. Rock will only be considered for payment when specialty equipment such as a hoe ram is needed. Rock excavation will be measured and paid per cubic yard of actual rock excavated. Quantities will be determined by the engineer/owner and agreed upon by the contractor.

WHEREAS, the execution of this Change Order will result in the addition of Bid Item "CO3-1 – Rock Excavation". This Bid Item will have an estimated quantity of 100 Cubic Yards at a unit price of \$95/CY for a total estimated cost of \$9,500. The contractor will only be paid for actual quantities of qualifying rock excavated.
