Whereas, the Town of Owasco is pursuing federal and state funding to maximize the affordability of the project for system users, and

Whereas, the New York State Infrastructure Improvement Act of 2015 provides the New York State Environmental Facilities Corporation (EFC) authority to provide grants to assist municipalities in funding clean water projects that protect public health.

Now, therefore be it resolved that the Town of Owasco, at their meeting held August 13, 2015, does hereby authorize the submittal of an application to the NYS Clean Water Grant program, due September 4, 2015, and does further authorize the Town Supervisor to execute any and all documents associated with the application.
