WHEREAS, pursuant to Owasco Town Code Section 116-82 the Town Board by Resolution may adopt the schedule of charges and rates for Sewer Service;

WHEREAS, pursuant to Owasco Town Code Section 144-30 the Town Board by Resolution may adopt the schedule of charges and raters for water serve to users outside the Water District;
