WHEREAS, on March 12, 2009 by Resolution 09-061 the Town Board appropriated up to \$40,000 to pay the cost of preparing a general map and plan and related expenses for providing sewer services to a portion of the town to be known as Town of Owasco Sewer District No. 3, which is not currently included within the boundaries of the existing Town Sewer District No. 1 and Sewer District No. 2; and

WHEREAS, Resolution 09-061, pursuant to Town Law Section 191-a, was adopted subject to permissive referendum; and

WHEREAS, Resolution 09-061 was duly published in The Citizen on March 21, 2009; and

WHEREAS, on January 4, 2010 by Resolution 10-23 from 1/4/10 the Town allocated an additional \$15,000 for a total of up to \$55,000 for expenses for the proposed Sewer District No. 3; and

WHEREAS, Resolution 10-23, pursuant to Town Law Section 191-a, was adopted subject to permissive

IEREAS, Resolution 10-23 was duly published in The Citizen on March 21, 2009; and

WHEREAS, the Town has appropriated a total of \$55,000.00 for a general map, plan and report, an Environmental Review, (SEQR/SERP), and General Funding Assistance for the proposed Sewer District No. 3; and

WHEREAS, the Town by this Resolution would like to allocate up to an additional \$4,900.00 for a total of up to \$59,900.00 for expenses for the proposed Sewer District No. 3; and

BE IT RESOLVED, that the Town Board hereby adopts this resolution pursuant to Town Law Section 191-a appropriating up to an additional \$4,900.00 to pay the cost of preparing and completing a general map and plan and related expenses for providing sewer services to a portion of the town known as Town of Owasco Sewer District No. 3, which is not currently included within the boundaries of the existing Town Sewer District No. 1 and Sewer District No. 2;

FURTHER RESOLVED, that the expenses incurred for the preparation and completion of such maps and plans and related expenses shall be a town charge, and shall be assessed, levied and collected in the same manner as other town charges; and

FURTHER RESOLVED, that if the Town Board shall thereafter establish or extend a sewer district and construct a sewer system pursuant to the Town Law, the expenses incurred by the Town for the preparation of the maps and plan and related expenses shall be deemed to be part of the cost of such improvement, and the Town shall be reimbursed the amount paid therefore, or such portion of that amount which the Town Board, at the public hearing held pursuant to Town Law Section 194, shall allocate against such district; and
