WHEREAS, a Resolution was adopted by the Town Board on February 14, 2013 introducing proposed Local Law No. 4 of 2013 and said Resolution established a public hearing relating thereto; and

WHEREAS, a Notice of Public Hearing with respect to said proposed Local Law was duly published in The Citizen, the official Town newspaper and a newspaper circulated in said Town on February 28, 2013, and proof of such publication has been filed with the Town Clerk, and

WHEREAS, a Notice of Public Hearing with respect to such Local Law was duly posted on the sign board of the Owasco Town Hall, and

WHEREAS, a Public Hearing upon said proposed Local Law was held at the Owasco Town Hall, 2 Bristol Avenue, Auburn, New York 13021, in the Town of Owasco, New York on March 7, 2013 and continued on this date, April 10, 2013, pursuant to such Notice and an opportunity to be heard was given at said hearing to those favoring or opposing passage of said proposed Local Law; and

WHEREAS, the Owasco Town Board by Resolution passed on this date issued a Negative Declaration under SEQRA for Local Law No. 4 of 2013.

WHEREAS, the Town Board has carefully considered the proposed Local Law; and after due deliberation, finds it is in the best interest of the Town of Owasco to adopt said Local Law;

NOW, THEREFORE, AFTER DUE CONSIDERATION, IT IS HEREBY,

RESOLVED, that the Town Board of the Town of Owasco hereby approves and enacts Local Law No. 4 of 2013 set forth below:

Local Law No. 4 of 2013

Section 40-1 of the Town Code of the Town of Owasco is hereby repealed in its entirety and replaced with the following:

§ 40-1. License required; term; fee; bond.

No person shall exercise the business or trade of auctioneer or sell any property at public auction or outcry within the Town of Owasco without first having obtained a license to act as such auctioneer. Such license may be issued by the Town Clerk of the Town of Owasco upon application, for a period of not more than one year, upon payment of a fee of \$50. Before any such license is issued, the applicant shall file in the office of the Town Clerk a duly approved bond in the sum of \$1,000 to the effect that he shall well, truly and honestly conduct such business as such auctioneer. Said fee and bond may be adjusted by Resolution of the Town Board.

Section 62-2 of the Town Code of the Town of Owasco is hereby repealed in its entirety and replaced with the following:

§ 62-2. Permit fee; duration.

The fee for such license or permit, to be paid at the time of the issuing of the same, shall be \$100 for a period not to exceed six months. Said fee may be adjusted by Resolution of the Town Board.

Section 136-3 of the Town Code of the Town of Owasco is hereby repealed in its entirety and replaced with the following:

§ 136-3. Application requirements; application fee.

A. An application for a license provided for under § 136-2 shall be made to the Town Clerk upon a form to be furnished by him. Said application shall state the name and address of the owner of the premises, the name and address of the applicant and the nature and extent of his interest in the business for which a license is desired, the location and plot plan of the tourist park or camp or automobile tourist park or camp and the number of units to be provided for therein, detailed plans and specifications of all buildings, structures, plumbing, sewer and drainage systems and lighting and any other information required by the Town Clerk.

B. Such application shall be accompanied by a fee of \$5 for every five units or less, plus \$1 for each additional five units or fraction thereof, which shall cover the required investigation, but, if a license is subsequently issued, said fees shall be applied on account of the license fee, but in the event that a license is not issued, such investigation fee shall be retained by the Town. Said fee may be adjusted by Resolution of the Town Board.

Section 78-12 of the Town Code of the Town of Owasco is hereby repealed in its entirety and replaced with the following:

§ 78-12 Floodplain development permits.

A. Purpose. A floodplain development permit is hereby established for all construction and other development to be undertaken in areas of special flood hazard in this community for the purpose of protecting its citizens from increased flood hazards and insuring that new development is constructed in a manner that minimizes its exposure to flooding. It shall be unlawful to undertake any development in an area of special flood hazard, as shown on the Flood Insurance Rate Map enumerated in § 78-6, without a valid floodplain development permit. Application for a permit shall be made on forms furnished by the local administrator and may include, but not be limited to, plans, in duplicate, drawn to scale and showing, the nature, location, dimensions, and elevations of the area in question; existing or proposed structures, fill, storage of materials, drainage facilities, and the location of the foregoing.

<u>B.</u> Fees. All applications for a floodplain development permit shall be accompanied by an application fee of \$50. Said fee may be adjusted by Resolution of the Town Board. In addition, the applicant shall be responsible for reimbursing the Town of Owasco for any additional costs necessary for review, inspection and approval of this project. The local administrator may require a deposit of no more than \$500 to cover these additional costs. Said fee may be adjusted by Resolution of the Town Board.

Section 119-3(B)(3) only of the Town Code of the Town of Owasco is hereby repealed in its entirety and replaced with the following:

Section 119-3(B)(3) Bulk items, such as furniture and household appliances not containing Freon may be disposed of after making prior arrangements with a Recycling Center employee, and paying the associated disposal fee. A fee schedule is available at the Recycling Center or the Owasco Town Hall. Said fees may be established and adjusted by Resolution of the Town Board.

Sections 144-10 and 144-11 of the Town Code of the Town of Owasco is hereby repealed in its entirety and replaced with the following:

§ 144-10 Taps and connections.

All connections to or taps of water mains for water service shall be made by the Water Department. A tapping or connection fee(s) may be established and adjusted by Resolution of the Town Board.

§ 144-11 Line specifications.

A. All private lines shall be installed, maintained, altered or replaced with Type K copper tubing which shall conform to ASTM Designation 888, latest revision, or plastic tubing with a tracer of the following widths and thicknesses:

B. All joints in Type K copper-tube service lines between the curb stop and meter shall be made with compression or flare fittings.

Section 136-5 of the Town Code of the Town of Owasco is hereby repealed in its entirety and replaced with the following:

§ 136-5. Hearing; fees; duration of license; display of license.

- A. The Town Board shall consider the report of the Town Clerk and shall, for that purpose, hold a public hearing upon notice prescribed by said Board upon such application and shall determine whether the proposed tourist park or camp or automobile tourist park or camp complies with this chapter.
- **B.** If such application is acted upon favorably by the Town Board, it shall direct the Town Clerk to issue a license to the applicant upon the payment of the following fees:
 - (1) For a tourist park or camp or automobile tourist park or camp or any combination of such: \$150.
 - (2) For each trailer: \$100 per unit.
- <u>C.</u> Each license shall be for a period from April 1 to March 31. The fee for such license shall not be prorated for any lesser period.
- <u>D.</u> Such license shall always be on display in the office of the tourist camp or park or automobile tourist camp or park.
 - E. Said fees may be adjusted by Resolution of the Town Board.

Section 144-23 of the Town Code of the Town of Owasco is hereby repealed in its entirety and replaced with the following:

§ 144-23. Tests for meter accuracy; charge.

Consumers, upon request, may have the meters serving their premises tested by the Water Department in their presence or that of a duly authorized representative. If the meter so tested shall be found to register not more than 103% or less then 97% of the amount of water actually passing through it, the actual expense, including overhead, incurred by the Water Department in removing, testing and replacing the meter shall be paid by the consumer.

Section 150-37 of the Town Code of the Town of Owasco is hereby repealed in its entirety and replaced with the following:

§ 150-37 Temporary signs.

Temporary signs over six square feet in area shall be erected only with a special permit. The applicant shall deposit with the Town Clerk \$1 per square foot of the total signs displayed (total single-sign area times total number of signs). Said deposit fee may be adjusted by Resolution of the Town Board. This deposit shall be refunded when signs are removed or shall be used by the Town to defray the cost of removing them. No temporary sign shall be posted earlier than 30 days prior to the advertised activity, and the signs shall be removed immediately following the activity's conclusion.

Resolution 13-072 to approve the rules and regulations governing the installation of a second water meter for permanent irrigation systems only as follows.

TOWN OF OWASCO WATER DEPARTMENT POLICY - IRRIGATION METERS

The following policy shall be incorporated into the Owasco Water Department Rules and Regulations governing the installation of a second water meter for permanent lawn irrigation systems. All pertinent sections of Chapter 144 – Water, of the Code of the Town of Owasco shall apply, in addition to this policy and the Owasco Water Department Rules and Regulations:

1. Application, Fee.

Any person desiring to purchase an additional water meter to purchase water for a permanent lawn irrigation system shall apply to the Water Department upon forms provided by the Water Department. Application shall be made by the owner of the premises or his agent. A fee of \$150.00 shall accompany the application, in addition to the cost of the meter and a backflow prevention device. The meter and backflow prevention device shall be provided by the Owasco Water Department at cost to the owner.

2. Inspection, Access to Premises.

The Water Department shall inspect the premises to determine the best location for the irrigation meter and backflow prevention device prior to installation. The filing of an application shall be deemed consent to access the premises at all reasonable times for the purposes of inspection, installation, maintenance, repair, meter reading or turning on or shutting off water.

3. Water Rates, Account.

The minimum water charge and standard water rates shall apply to the irrigation meter. No sewer rates shall be charged to the irrigation meter. A separate account shall be established by the Water Department for the irrigation meter.

4. Backflow Prevention Device, Final Inspection.

The installation of a backflow prevention device, in a location approved by the Owasco Water Department shall be required on all lawn irrigation meters. The backflow prevention device shall be provided by the Owasco Water Department at cost to the Owner and installed by the Owner or his agent prior to installation of the water meter. The Owasco Water Department shall perform a final inspection and approve the installation of the backflow prevention device and irrigation system prior to turning on the water to the irrigation meter.

5. Tampering With Equipment.

No person other than an employee of the Water Department shall interfere with or remove any water meter, backflow prevention device, sealing device or coupling from any meter installation after it has been placed in service by the Water Department.

6. Curtailing or discontinuing water use during shortages.

The Water Department shall have the right to curtail the amount of water supplied in the event that its supply becomes limited. The Water Department, in case of a shortage of water, may limit or prohibit the use of water for sprinkling of lawns or gardens or for any purpose not deemed necessary for the maintenance of public health. Where water is wastefully or negligently used on a consumer's premises seriously affecting the general service, the Water Department may discontinue the service of such premises if conditions are not corrected within 24 hours after giving such customer written notice, or, if an emergency exists, it may discontinue service without notice.
