<u>Resolution 13-175</u> Water Quality Improvement Project Grant from the NYS Department of Environmental Conservation

WHEREAS, the Town of Owasco in Cayuga County, is requesting a \$2,000,000 Water Quality Improvement Project Grant from the NYS Department of Environmental Conservation through Round 11 of the Water Quality Improvement Project Program; and

WHEREAS, proposed Sewer District No. 3 is currently served by private, on site wastewater treatment systems (OWTS) which have experienced failures due to high seasonal water tables, impermeable soils, and small lot sizes and the failure of these on site systems negatively affect Owasco Lake by releasing an abundance of bacteria and nutrients such as phosphorous and nitrogen into the lake, causing excessive algae growth;

WHEREAS, Sewer District No. 3 will involve the construction of a grinder pump/low-pressure collection system to serve the District, as well as improvements to existing sewer infrastructure/facilities, including the Oakridge Pump Station and Interceptor Sewer in the Town, in order to convey wastewater to the City of Auburn WWTP for treatment:

WHEREAS, the proposed project would eliminate further contamination of Owasco Lake as a result of OWTS failures; and

WHEREAS, the aforementioned grant requires 15 percent local share of the total grant requested, which equals \$300,000 based on the maximum grant available of \$2,000,000.

NOW, THEREFORE, BE IT RESOLVED, that the Town of Owasco Board is in support of the Project and the submission of a grant application to the Round 11 Water Quality Improvement Project Grant Program in the amount of \$2,000,000.

BE IT FURTHER RESOLVED, that the Town of Owasco Town Supervisor, shall be the lead applicant contact person and is authorized to execute all financial and/or administrative processes relating to the implementation of the program.

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately.
