- Resolution: To Appoint Steve Simmons as Chairperson of the Recreation Board for 1 Year ending December 31, 2012 for a stipend at \$2,000 per Year.
- Resolution: to appoint Elizabeth Bowman as Full Time Deputy Clerk Non Competitive at her current rate.
- Resolution: RESOLUTION FOR STANDARDIZATION FOR WATER METERS
- Resolution: to accept sales by Auctions International of the following items
- Resolution: to decline the sale of the 1984 Ford 900 Dump Truck by auctions International for the purchase price of \$1,880.00
- Resolution: The Town of Owasco fully supports the grant application to the New York State 2011
 2012 Local Government Efficiency Grant Program for the purchase of a Sewer Monitoring System to be utilized by the towns of Owasco, Fleming, Sennett, and Aurelius.

- Resolution: to increase Water Service Tap Fee from \$650.00 to \$1200.00 to cover minimum costs to the Town.
- Resolution: To charge a Sewer Service Tap Fee of \$1,200.00 to cover minimum costs to the Town. If the Service Tap is already installed there will be an Inspection Fee of \$75.00.
- Resolution: to direct the Town of Owasco Code Enforcement Officer to enforce the Property Maintenance Section of the Code of the Town of Owasco sections 111-5 D. Open Areas and Parking Spaces and 111-13 Enforcement sections A. B. and C, and the Property Maintenance Code of New York State section 302.4 Weeds, for the 2012 season.

The Code Enforcement Officer shall determine which properties are not in compliance with the Property Maintenance Codes and shall issue a violation notice directing that the properties be brought into compliance within 10 days of said notice.

Should the violation continue, the Town will solicit 3 estimates from insured Lawn Maintenance Contractors to bring the above properties into compliance with the Codes. The property owner will then be billed for the costs incurred by the Town. If payment is not received, the Town will commence an action in small claims court for collection of said charges, plus appropriate costs.
